The property is set on Torriano Ave, nearest tube station being Kentish Town (Northern line) and close to Kentish Town Thameslink, local bus services, shops, cafes and restaurants. Camden Town is a bus ride away from Kentish Town Road & Camden Road, for its attractions including Camden market alongside The Regents Canal. The Kings Cross area is served by bus services from Brecknock Road for its amenities including Kings Cross rail stations, St Pancras Eurostar services, the Regents canal, Granary Square & the shops and restaurants of Coal Drops Yard.

The flat offers well-proportioned living accommodation and comprises a reception room with access to a private balcony, a separate kitchen, a windowed bathroom, a separate wc, two double bedrooms and a room that is being used as a workroom, also with access to the private balcony.





